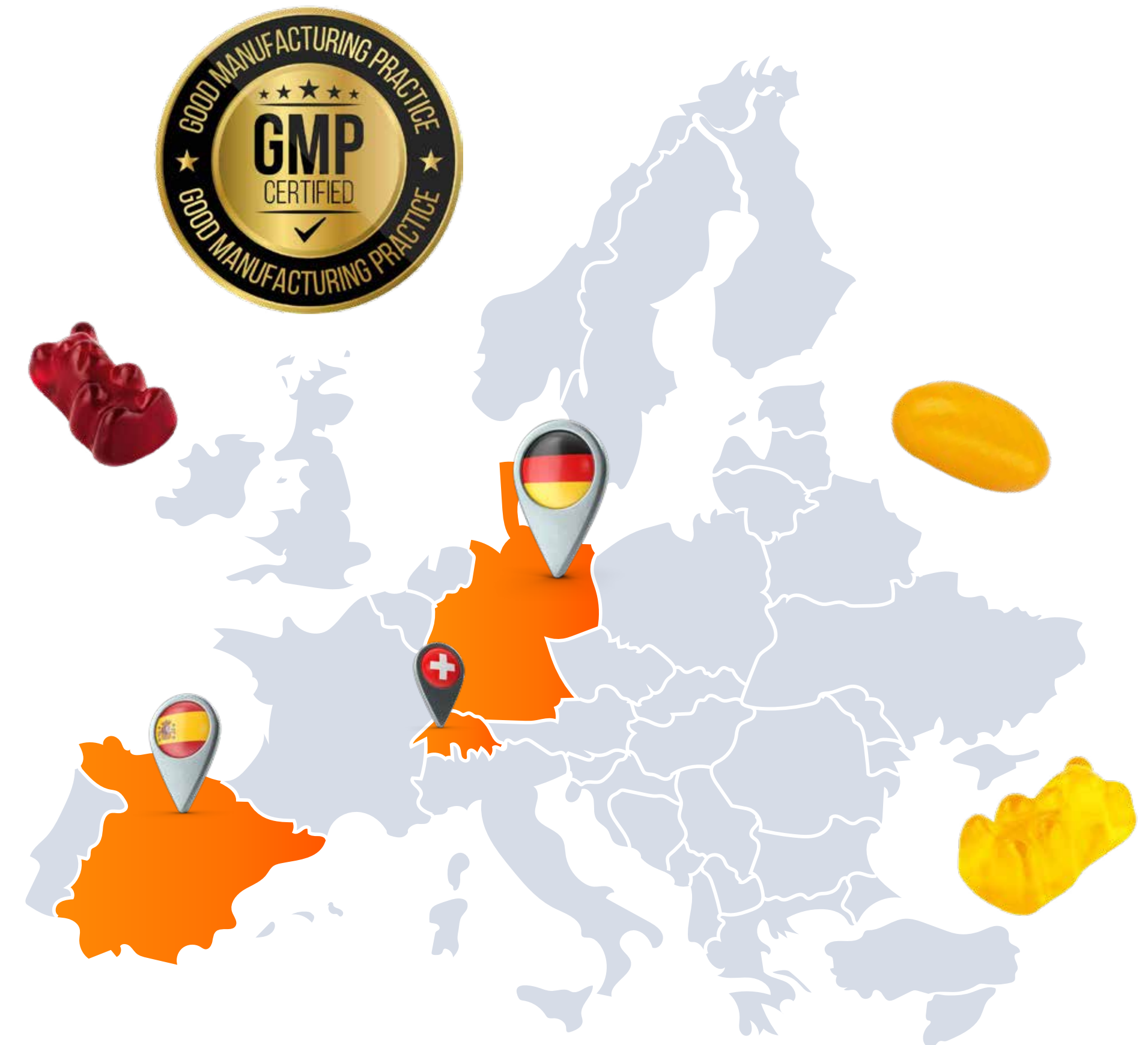

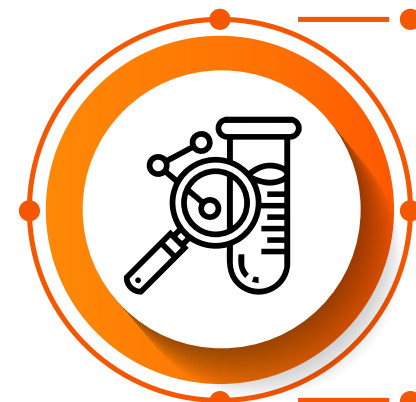

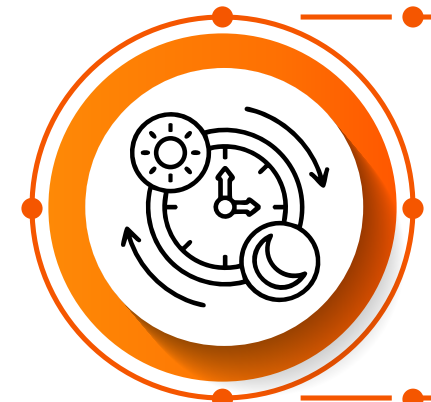
QUALITY & CERTIFICATIONS *(At a Glance)*



Standards & Sites: EU manufacturing (**Germany/ Spain/ Switzerland**) under GMP and HACCP; typical site certifications include ISO 22000/FSSC 22000, ISO 9001, and IFS/BRCGS. Alignment with US 21 CFR 111 for exports.



Testing & Release: Raw-material ID/purity, contaminants (e.g., heavy metals, pesticides), in-process controls, and finished-product assay/microbiology. **Each batch ships with a CoA and release dossier.**



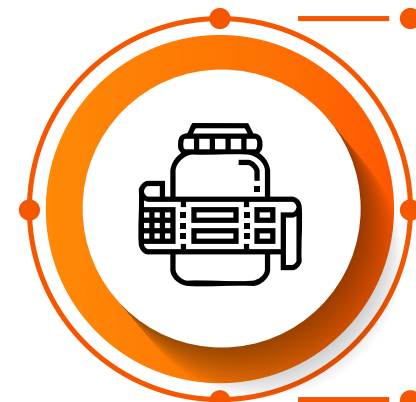
Stability: ICH-style accelerated and real-time studies to substantiate shelf life; **photostability where needed.**



Compliance & Labels: Claims and artwork **prepared for EU/UK, KSA/GCC, and USA/CA requirements** (nutrition/health claims, allergens, mandatory statements).



Traceability: Full lot traceability, supplier qualification, and recall readiness; optional QR/serialization.



Packaging Safety: Food-contact compliant materials; validated seals, tamper-evidence, and child-resistant options.

CAPSULES & SOFTGELS

Hard capsules (vegan HPMC/cellulose or gelatin) and **softgels** (bovine/fish/vegan) for vitamins, minerals, botanicals, omega oils, probiotics, adaptogens, and blends.

Clean-label choices (titanium-dioxide-free, allergen-controlled, sugar-free, etc).

Typical fills: 50–1,200 mg powders; 200–1,500 mg oils.

HDPE/PET bottles (Jar).

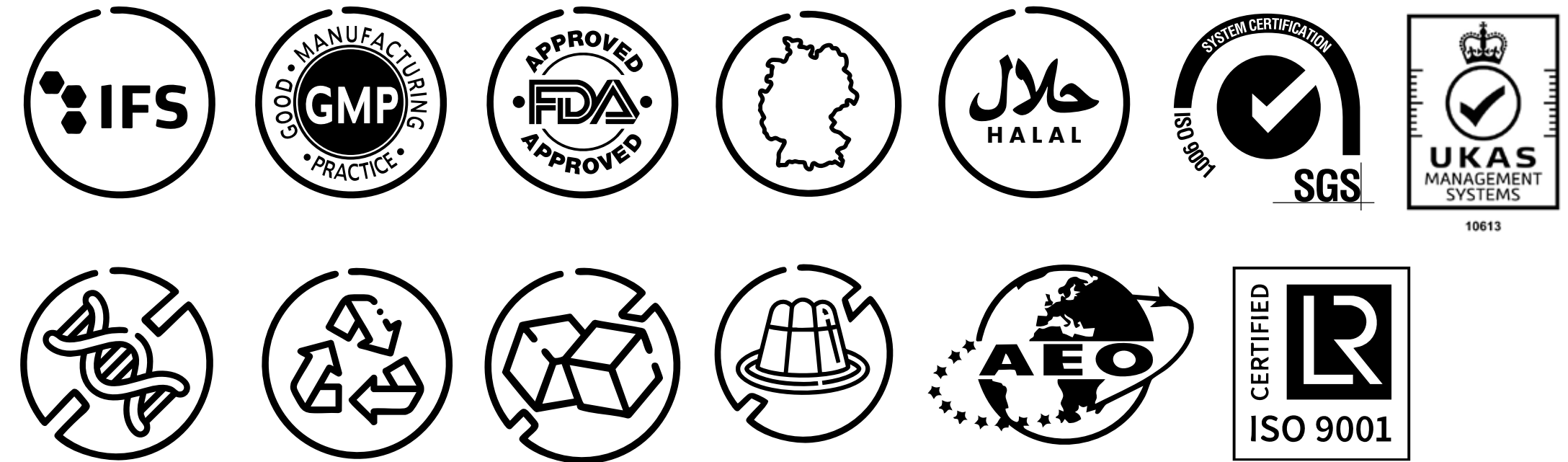


DRINKABLE SHOTS *(10–25 ml)*

Single-dose vials for your formula.

Also available for our **ready-to-label turnkey formulas** for energy, sleep, focus, immunity, joints, beauty, digestion and more.

Flavour masking, low- or no-sugar options, heat-stable colour/flavour systems.



AVAILABLE BOTTLING OPTIONS:

Glass or PET vials with tamper-evident closures

Choose between **10 ml and 25 ml** shots, packed as **10 or 20 vials (10 ml)** and **14 or 30 vials (25 ml)**.



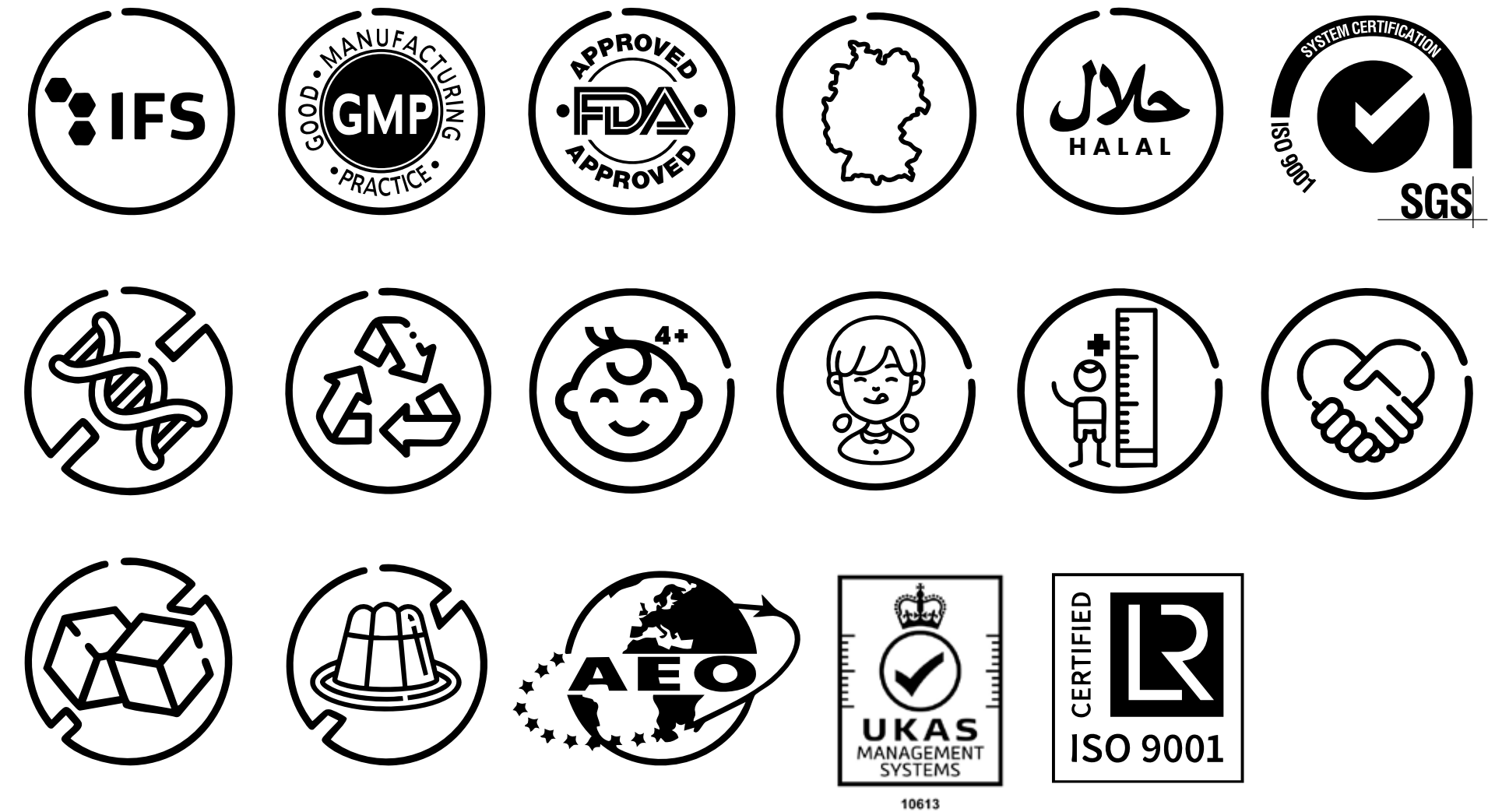
GUMMIES & JELLY BEANS

High-appeal delivery in pectin/gelatin/vegan systems; reduced-sugar or sugar-free options.

Jelly-bean format (non-gummy) with excellent stability in warm climates and low stickiness.

Supports multivitamins, minerals, fiber, collagen, botanicals, sleep/calming and kids' formulas.

Natural flavors and colors available; texture profiles from soft-chew to firm bite.

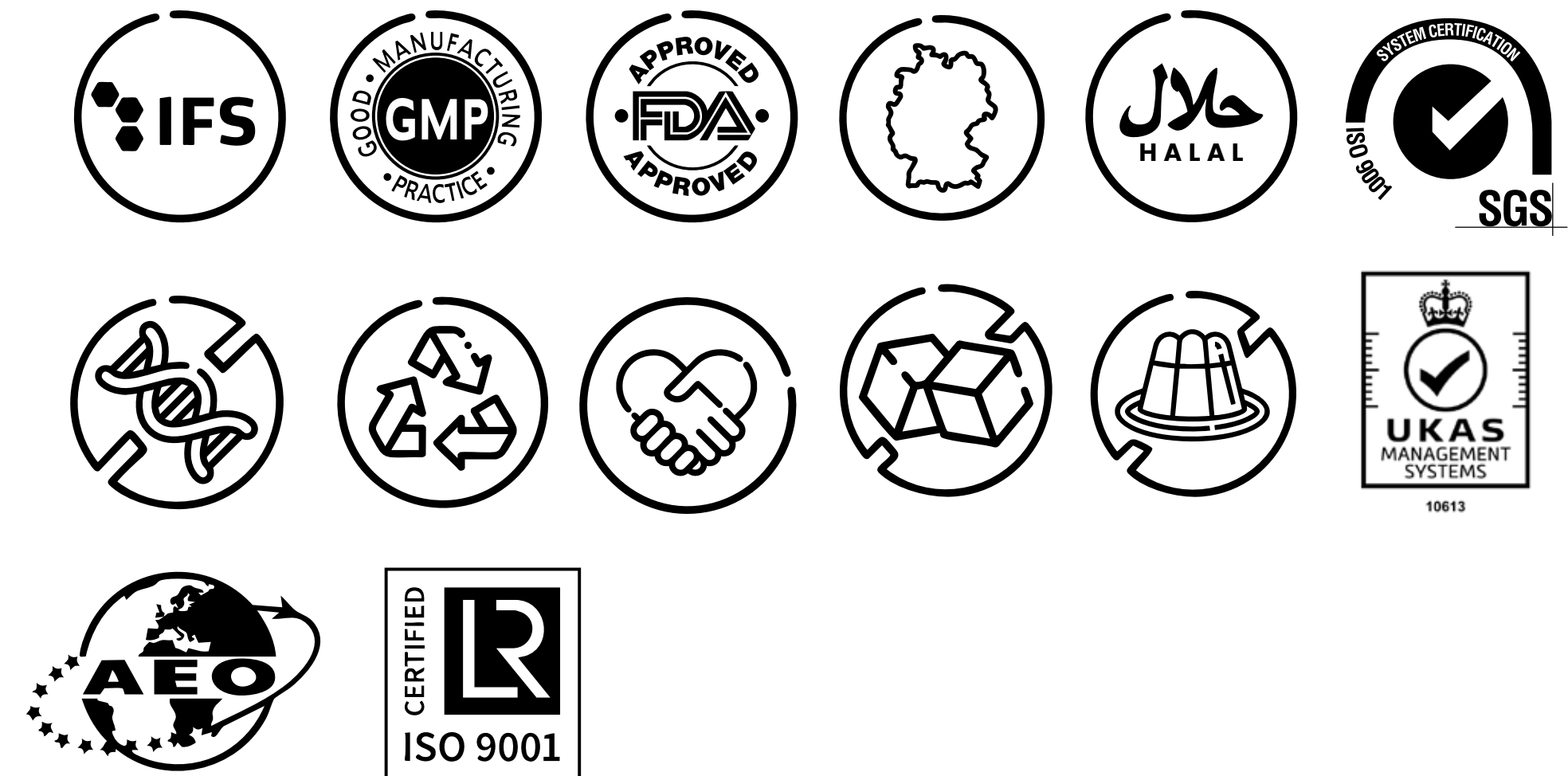


LIQUIDS & POWDERS

Available Formats:

Liquids: syrups, drops, tonics; true solutions, suspensions, and oil-in-water emulsions (incl. liposomal/nano options).

Powders: water-soluble or direct-to-mouth blends; options for effervescent, agglomerated, or granulated systems.



PACKAGING OPTIONS

Bottles (30–500 ml)

Amber glass or PET; calibrated droppers, pumps, or measuring cups; tamper-evident and child-resistant closures.



Sachets/Stick Packs:

on-the-go single doses—powders (2–20 g) and liquid sticks (5–30 ml) with long shelf stability



Formulation advantages

- Taste masking and gentle sweetener systems (low/no sugar).
- Flow aids & anti-caking for powders; viscosity and mouthfeel tuning for liquids.
- Microencapsulation for sensitive actives (e.g., probiotics, minerals, botanicals).

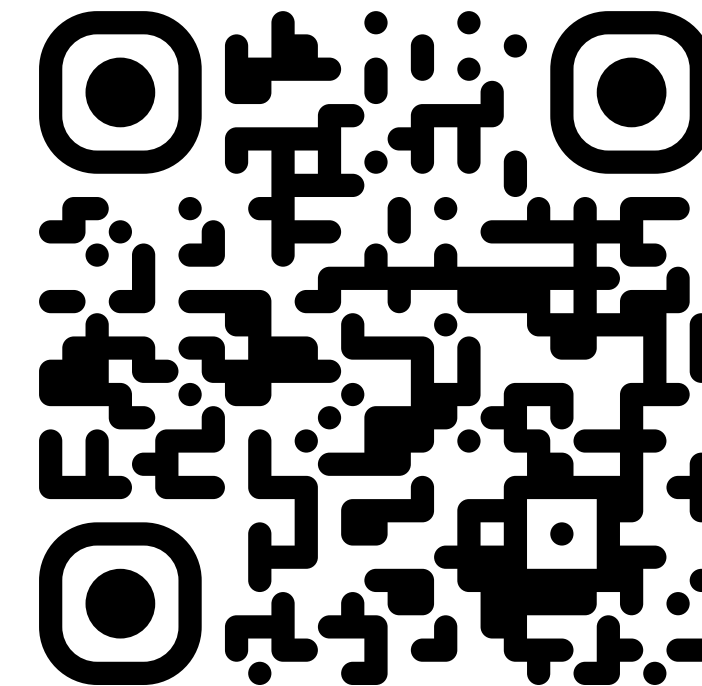

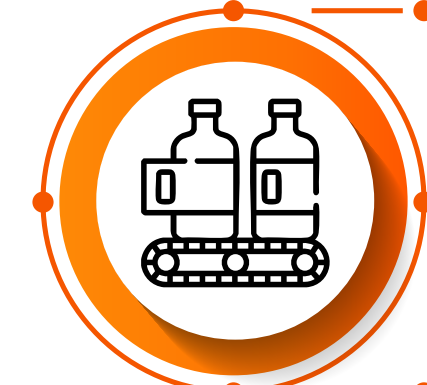

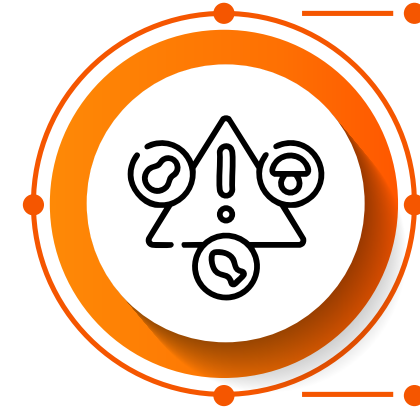
